

MESI CAMP

PARENT CONTRACT

In consideration of my child's participation in MESI Summer Camp, I agree to the following:

1. I understand that camp space is available on a first come first served basis. Once a camp session has reached capacity, no further campers will be admitted. No exceptions
2. Summer Camp sessions are \$125.00 per week. This does not include field trips fees for full time campers which will be an extra cost.
3. Camp sessions must either be:
 - a. Paid in full at the beginning of the camp season or,
 - b. Paid by 5pm on the Monday prior to the weekly session, space permitting. Please note, spaces fill fast.
4. I agree to pay a one-time non-refundable registration fee of \$100.00 to cover the cost of the camp such as securing field trips, T-shirt, camp fees, insurance etc. I also understand replacement shirts will be available for \$15.00 each.
5. I understand I can pay for camp at the MESI CAMP location SSIS Elementary school 845 S. School Ave. or online at www.MESICAMP.com
6. I understand that camp hours are Monday – Friday 8am – 4pm. I understand that staff will be onsite at 7:50am and that my child must be picked up no later than 4:05pm. I understand that if my child is not picked up by 4:05pm for regular pick up or 5:30pm, after care pickup. I will be charged a late pick up fee of \$5.00 per 15 minutes. Late fees are due no later than Friday at 5:30pm. Failure to pay the fee by the end of the current week (Friday) shall result in denied access to future camp sessions.
7. In order to protect the welfare of all campers and staff, all children attending camp sessions must be free of head lice, scabies or any other communicable or contagious condition and must exhibit proper hygiene. Any camper who does not exhibit proper hygiene or is suspected of a communicable or contagious condition will be immediately removed from camp and not permitted to return until the hygiene issue has been rectified or, in the event of a communicable or contagious condition, without a physician's release to do so.
8. Summer Camp has a Zero Tolerance policy on bullying. Bullying in any form will **NOT** be tolerated and will result in immediate expulsion from camp for the session without refund. No exceptions.

9. I give permission, for my child to travel to and from field trips on buses or through contracted providers that are provided through MESI CAMP. By signing this agreement, I give my child permission to attend the trips listed on the camp schedule. Without this signed agreement, I understand that my child will not be allowed to attend any planned trips. Field Trips will be held on Tuesdays, Wednesdays and Fridays, may be subject to change.

10. I understand that campers are required to travel to and from the field trips on the transportation provided, unless proper arrangements have been made and agreed to in writing.

11. I understand that MESI Camp has a semi open-door policy. Only authorized parents and guardians may visit their children in our facility approval of the site coordinators or senior staff.

12. Authorized parents, guardians or designated persons must personally sign the child in and out when dropping off and picking up.

13. I understand that my child must follow camp guidelines that are included in the parent handbook. I understand that my child's failure to follow rules can result in discipline (depending on the severity) leading up to suspension or dismissal from camp.

14. I understand that MESI CAMP reserves the right to remove my child from MESI Camp for just cause which includes, but is not limited to:

- a) Hygiene issues
- b) Communicable and/or contagious conditions
- c) Late payment for future sessions
- d) Late pick up
- e) Failure to comply with Summer Camp Rules and policies

15. I understand that if I have a concern or comment to express myself in a positive and professional way that is in no way derogatory or demeaning to the MESI Administration, site coordinators or MESI Staff and volunteers. I will always consult the Site Coordinator or Senior Staff with any issues or concerns.
